The SELS have a variety of resources to share with families depending on their specific need. GESD partners with local agencies to bring in services for students and their families who need greater assistance. GESD implements SEL curriculum based on site needs to support every student and teacher.

(b)(i) During the period of the ARP ESSER award established in section Start Printed Page 212022001(a) of the ARP Act, an LEA must regularly, but no less frequently than every six months (taking into consideration the timing of significant changes to CDC guidance on reopening schools), review and, as appropriate, revise its plan for the safe return to in-person instruction and continuity of services.
