Arizona School Tax Credit Contribution Form

School is more than a classroom education. Students learn, grow and experience success through a variety of extracurricular activities and student-interest clubs. Active students have better grades, stay in school and develop leadership skills, or uncover talents they never knew they had.

Arizona tax law allows taxpayers a tax credit of up to \$200 for individuals or up to \$400 for married couples filing jointly. Tax credits allow any Arizona state resident to submit a donation and get a dollar-for-dollar return on their state taxes. You get every penny back when you file your state return either as a reduction in your tax bill or added to your refund. The tax credit is available to all taxpayers, not just those with children in public schools. Of course, all tax matters are subject to the limits of your tax liability. Please consult a tax professional for more information.
